Procedures for the submission of "actual" files by digital platforms to the DGFiP (article 242 bis of the General Tax Code)

How to submit a file via the professional area of the "impots.gouv.fr" website ?

Any person who wishes to submit a file on behalf of a platform subject to the provisions of article 242 bis of the CGI must first hold a professional space on the "<u>impots.gouv.fr</u>" website in which they may submit this file via an online service.

In order to use the service called « Déclarer Économie collaborative » (submit a sharing economy file), the user must however be authorised to use at least one online service on behalf of the platform (by way of membership, substitution or delegation).

The terms and conditions for creating a professional space, joining, substituting and delegating online services can be consulted on the "<u>impots.gouv.fr</u>" website.

The submission of a file is only possible (after clicking on the aforementioned link) if the reporting platform is identified by a French SIREN registration number. Consequently, if a reporting platform does not hold a SIREN number, it will have to register in order to obtain a SIREN number first.

If the reporting platform has no liabilities in France other than tax obligations, it must register with the relevant department of the DGFiP. The registration procedures for foreign platforms are specified in the "Registering sharing economy platforms" document.

How to access the professional space ?

The persons holding a professional space in which they are entitled (by way of membership or delegation) to use at least one online service on behalf of platforms (holding a SIREN number) shall successively carry out the following steps :

- Connect to the professional space, on the "impots.gouv.fr" website, in the your professional space section : <u>Connexion à mon espace professionnel</u>;

- access to the filing space : Mes services / Déclarer / Économie collaborative.

Please note: the SIREN number of the platform, for which the user holding the professional space is entitled to at least one service, must be identical to the SIREN number of the platform given in the declaration in the ENT003 section.

Reminder of the technical prerequisites for submitting files

- The encryption methods are described in § 2.2 of the <u>Sharing Economy Technical Manual</u> <u>published</u> on the "impots.gouv.fr" website (in the "<u>Useful documents</u>" section). The file must be compressed in GZIP format before it is encrypted.

- Prior to submission, the file must ben encrypted using a public-key. A public encryption key is created specifically for the production environment.

A "Guide to cryptography" and the "<u>P ublic-key for production files</u>" are available in the "<u>https://www.impots.gouv.fr/portail/node/13320?l=en</u>" area of the "impots.gouv.fr" site (in the "Useful documents"

section).

- the XSD data collection schema is published in the "<u>Sharing economy and digital platforms</u>" section of the "impots.gouv.fr" site (in the "Useful documentation" section)

Technical assistance for the platforms

The platforms can access all the information available on the "impots.gouv.fr" website, under <u>Sharing Economy and digital platforms</u> section. In particular, the BOFiP (administrative commentaries), the technical specifications, the XSD data collection schema, the guide to cryptography, the examples of valid files and the public-key for production files are available. If necessary, the administration can be contacted for assistance through the following means :
